The 7th annual Marana Bluegrass & Acoustic Music Festival is once again being hosted by the Town of Marana and the Desert Bluegrass Association. The festival is being staged at the Gladden Farms Community Park, same location as last year in Marana. If you wish to participate as a vendor, please complete the applications Exhibit B (page 2). We will be able to accept credit card payments or checks for your booth. Should you email your application be sure to email your credit card receipt with the application. Credit card acceptance details are on the festival website.

Arts and Craft Booths are \$50.00 for a 10 x 10 foot space for the three day event. Exhibitors must provide all canopies, weights for canopies, tables etc. The surface area is grass so staking is available.

Food Vendors are \$100.00 for the three day event. A Pima County Health Permit is required unless the food is prepackaged. **Please provide a copy of your Town of Marana Business license, Pima County Temporary Food Establishment Permit and Certificate of Insurance with your signed Exhibit B with your application**

VENDORS NOTE: Marana Business License is Required (\$50.00). For details call: 520-382-1999. You will need to provide your own quiet generator 70DB or below, as there is no power available. You will also need to bring your own water and be totally self-contained. Beer and Alcoholic beverages are strictly prohibited. Tables and chairs will be provided in a joint eating area in front of the vendors. Vendors will be able to set up at 10:00AM Friday March 15, 2018. Due to the new location once vendors are parked they will not be able to leave the premises until Sunday after the festival has ended. The bollards will be removed for your access during the set up time and at the close of the festival only. Personal vehicles will need to park in the designated parking lot located close as reasonably possible. Vendors must provide their own lights, fire extinguisher and tie-downs for any propane tanks and are responsible to dispose waste in the appropriate containers. Trash receptacles will be available for your use. Pima County Temporary Food Establishment Permit (\$60.00) Must be purchased at least 14 days prior to event. For Details call 520-724-7908 or email chfs@pima.gov.

Vendors accepted for booth space rental should make payment by **February 1, 2019**. All late payments, if accepted must be made in cash or credit card. Attendance Expected for the event approximately 1000 people. Should you wish to bring a RV for camping please let us know so we can advise the camp host and can obtain information to properly assign you a space.
