Upon approval of vendor application, you will be required to provide the following:

1. Food vendors, Certificate of Liability Insurance *and endorsement* naming the *Town of Marana and the Desert Bluegrass Association* as an additional insured;
2. All vendors, Copy of their current Marana Business License;
3. Food vendors will also need to provide a copy of their current Permit to Operate issued by Pima County.

The vendor application, supporting documents and payment need to be received by December 31st

City of Marana insurance requirements for Food Vendors:

Certificate of Insurance (COI) and Endorsement, naming the Town of Marana as an additional insured for one (1) million dollars per occurrence/two (2) million dollars aggregate. Minimums and maximums are subject to review and the Town of Marana reserves the right to request higher amounts. The policy must be primary and non-contributory. The Certificate Holder portion of the COI must say, "Town of Marana, 11555 W Civic Center Dr., Marana, AZ 85653. "

Arts and Craft Booths are \$50.00 for a 10 x 10-foot space. Exhibitors must provide all canopies, weights for canopies, tables, chairs, etc. The surface area is grass so staking is available.

Food Vendors are \$125.00 for the three-day event. A Pima County Permit to Operate is required. You will need to furnish your own power, potable water and if using tents, you will need to furnish your weights, tables and chairs. **Your food truck or trailer must remain on site for the entire event.**

Vendors will need to provide their own lights, fire extinguishers and tie downs for any propane tanks and generators if needed. Trash receptacles will be available for your use and all trash must be disposed of in the appropriate containers. Tables and chairs will be provided in a joint eating area in front of the vendors. Vendors will be issued wristbands and parking passes when they arrive to set up and must be worn throughout the festival. Camping for vendors will be available, please let John know for your complimentary camping. Vendors will be able to set up at noon on Friday. We look forward to your participation and wish you great success at our festival!

AGREEMENT BETWEEN TOWN OF MARANA AND DESERT BLUEGRASS ASSOCIATION

Release and Indemnification Agreement. In consideration of the acceptance of my Vendor Application for the Desert Bluegrass Festival, I do hereby, for myself, my children, my heirs, executors and assign, release the Town of Marana (Town) and Desert Bluegrass Association, and their respective agents, officials, and employees from liability for any harm, injury, or damage, which I, or my minor children, may suffer while participating in the above-described event. This includes all risks that are connected with the event whether foreseen or unforeseen. Additionally, I agree to defend, save, hold harmless, and indemnify the Town and Desert Bluegrass Association, and their respective officials, employees agents, successors, and assigns from and against any and all manner of claims, suits, lawsuits, action or actions, causes or causes of action, liabilities, damages, and other claims and demands of whatsoever nature or kind, in law or in equity, in tort or in contract or otherwise caused by or resulting from my errors, omissions, or negligent or intentional acts in connection with the above-described event. I am of lawful age and legally competent to execute this Agreement. I understand the terms of this Agreement and have agreed to its terms as my own free act.

Food vendors are required to have a minimum of \$1 million in liability insurance coverage, naming themselves, the Desert Bluegrass Association, and the town of Marana as the insured. *"as per the Marana Insurance Requirements above"*

If I am acting on behalf of an organization, I certify that I am the agent of the organization, I am acting on the organization's behalf and I am duly authorized to execute this Release and Indemnification Agreement on the organization's behalf. **Cancellation:** No refunds will be issued for cancellations within **30** days of the first day of the event.
