<u>Arts and Craft Booths</u> are \$50.00 for a 10 x 10-foot space. Exhibitors must provide all canopies, weights for canopies, tables, chairs, etc. The surface area is grass so staking is available.

<u>Food Vendors</u> are \$125.00 for the three-day event. A Pima County Permit to Operate is required. You will need to furnish your own power, potable water and if using tents, you will need to furnish your weights, tables and chairs.

Vendors will need to provide their own lights, fire extinguishers and tie downs for any propane tanks and generator's if needed. Trash receptacles will be available for your use and all trash must be disposed in the appropriate containers. Tables and chairs will be provided in a joint eating area in front of the vendors. Vendors will be issued wristbands and parking passes when they arrive to set up and must be worn throughout the festival. Camping for vendors will be available, please let Deb or Ed know for your complimentary camping. Vendors will be able to set up at noon on Friday.
